## APPROPRIATE USAGE

The Park provides Wi-Fi access to members for casual use. Casual use is defined as checking email, weather, news, online banking, and casual web browsing. The network's limited bandwidth is shared between all members and to assure bandwidth is not unfairly utilized, member usage will be monitored.

Cushing Memorial Park Inc. shall not be liable to MEMBER for any damages arising from any event that is out of the control of Cushing Memorial Park Inc. Neither shall Cushing Memorial Park Inc., be liable for indirect, special, incidental, exemplary, consequential, or any other form of money damages, including but not limited to, lost profits, or for the loss of data or information of any kind, however caused and arising out of or in connection with the performance of Cushing Memorial Park Inc., or the provision of services or performance hereunder, whether based in contract, tort, or any other legal theory, and whether or not Cushing Memorial Park Inc., has been made aware of the possibility of such damages. In no event shall liability exceed a refund of amounts actually paid by MEMBER for the then current year for Wi-Fi usage (\$0).

Bandwidth: MEMBER acknowledges that the bandwidth provided by Cushing Memorial Park Inc., is a shared service and may be subjected to interruptions of service due to weather, damage, loss of upstream service providers, etc. Factors such as network congestion and MEMBER's modem settings can affect service speeds. Cushing Memorial Park Inc., reserves the right to manage its Networks to provide for maximum efficiency. As a user, you must ensure that your activities do not improperly restrict, inhibit, or degrade any other user's use of the service or Cushing Memorial Park's Inc., ability to deliver and monitor the service and do not represent (in the sole judgment of Cushing Memorial Park Inc.) an unusually large burden on the network itself. Users found to be (in Cushing Memorial Park's Inc., sole judgment) users of excess bandwidth may have their accounts terminated, suspended. Cushing Memorial Park Inc. will use reasonable efforts to notify a MEMBER prior to service termination for excessive bandwidth use.

MEMBER shall use reasonable efforts to minimize unnecessary network traffic and interference with the work of other users of interconnected networks. CUSHING MEMORIAL PARK, INC. reserves the right to terminate service, if in CUSHING MEMORIAL PARK's, INC. sole determination MEMBER utilizes excessive bandwidth. The Service is provided to MEMBER for their private non-commercial use.

## INAPPROPRIATE USAGE

Excessive bandwidth usage by a member is defined as but not limited to: streaming or downloading movies, video, TV, music, torrents, online gaming, VOIP or other large downloads and may result in a restriction of access. At the Cushing Memorial Park's, Inc. sole discretion, devices primarily dedicated for the above purposes will not be registered.

Note: Members requiring an excessive amount of bandwidth should secure dedicated service from an ISP. Cushing Memorial Park's, Inc. bandwidth (with the exception of the Clubhouse gateway) is provided by the generosity of other members. If you decide to secure a dedicated ISP, then Cushing Memorial Park, Inc. would appreciate the opportunity to add you to the network as a gateway. Please contact support listed above.

1<sup>st</sup> offense –warning

2<sup>nd</sup> offense – one week blockage

3<sup>rd</sup> offense – two week blockage

4<sup>th</sup> offense – minimum suspension of Wi-Fi for remainder of season (April 1 – March 31) and review of membership

## ILLEGAL USAGE

The Cushing Memorial Park, Inc. Wi-Fi mesh system may not be used for any illegal activity. Members are responsible for any invited guests usage, and are expected to make sure that guests understand the park policies.

Members and/or guests that are caught using the Wi-Fi for illegal purposes will have their access blocked immediately and membership is subject to revocation.

## REGISTRATION

Members must register **each** Wi-Fi capable device by accessing the Contact Wi-Fi form on the Cushing Memorial Park, Inc. Web Site **one week prior to arriving in the park.** **There is no full-time Wi-Fi administrator. Wi-Fi registration is administered by volunteers on a time available basis.**
